Application must be completed and submitted by a representative, who has permission on behalf of the organization, to present the request and needs of a group or community.

Multiple applications may be submitted; However, organizations can only receive funding on one project per year.

Recipients' organizations and projects should serve Capital Credit Union's region of Northeastern Wisconsin. This includes Brown, Calumet, Dane, Dodge, Door, Fond Du Lac, Kewaunee, Manitowoc, Marathon, Marinette, Menominee, Oconto, Outagamie, Portage, Shawano, Sheboygan, Waupaca and Winnebago counties.

Additional Information

The Capital Credit Union Elevate Communities program develops and supports initiatives brought forward by civic organizations, municipalities and other service organizations to fill financial limitations that may hinder a community from obtaining resources or doing projects of need. The Elevate Communities Program, subject to the availability of funding, will provide a limited number of project funds to enhance the quality of life in communities, improve services offered by organizations, and help provide funding to projects and tools that may not be possible to obtain without this funding.

EC offers a partnership to be established between the recipients and Capital Credit Union for a determined amount of time set by project need. This encompasses employee volunteer work (if requested), project materials, marketing and more. The scope of the partnership will be determined between recipients and Capital Credit Union prior to funds being dispersed.

This program is not to be viewed as an ongoing funding resource. The EC program may be discontinued at any time by Capital Credit Union.

Capital Credit Union reserves the right to accept or decline recipients and to disperse funds. If Capital Credit Union does not receive enough eligible applicants to use the total program funding of \$100,000, they can withhold the remaining funds.
